

**WARRICK COUNTY COMMISSIONERS
ORDINANCE NUMBER 2000- 6**

**An Ordinance Rescinding and Replacing
Certain Portions of Ordinance No. 1994-15 and No. 1997-14
Establishing Fee for TB Testing**

WHEREAS, the Board of Commissioners of Warrick County, Indiana (“Board” and “County” respectively) previously entered and passed Ordinance Number 1994-15 and Ordinance Number 1997-14 establishing a fee for TB testing; and

WHEREAS, this Board has determined a need to modify certain terms of the Ordinance; and

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners of Warrick County, Indiana, as follows:

1. Paragraph (B) of § 132.02 of said Ordinance is hereby rescinded, and in its place there shall be substituted the following paragraph:

“§ 132.02, Par. (B): The fee for Mantoux (TB) testing shall be the actual cost of the testing plus a \$1.00 testing fee.”

2. Paragraph (C) of § 132.02 of said Ordinance is hereby revised in that it shall now be identified as Paragraph (D).

3. Paragraph (D) of § 132.02 of said Ordinance is hereby revised in that it shall now be identified as Paragraph (E).

4. A new Paragraph (C) of § 132.02 of said Ordinance shall be inserted and shall read as follows:

“(C) The Public Health Nurse may give TB certification class to any interested party. The cost of said certification shall be \$10.00.”

5. That attached for reference hereto, made a part hereof, and marked as “Exhibit A” is a revised draft of the entire § 132.02 reflecting the foregoing revisions.


This ordinance shall be in full force and effect from and after its passage by the Board of Commissioners of the County of Warrick, State of Indiana.



§ 132.02 FEE FOR TB TESTING.

(A) There shall be a fee charged and collected for the service of Mantoux (TB) provided by the County Department of Health and Animal Control as set out in division (B) unless the fee is waived under division (C).

(B) The fee for Mantoux (TB) testing shall be the actual cost of the testing plus a \$1.00 testing fee.

(C) The Public Health Nurse may give TB certification class to any interested party. The cost of said certification shall be \$10.00.

(D) The Department of Health and Animal Control may waive the fee imposed herein:

(1) For those persons who have no private or public insurance program available which will pay the fee on their, or their dependents, behalf, and

(2) Where such person has demonstrated to the satisfaction of the Department, pursuant to standards adopted by the Department, that such person does not have the ability to pay such fee for such person or a dependent.

(E) The fee imposed by division (B) shall be deposited in the Local Health Maintenance Fund to be used for the purposes for which said fund exists.
