

WARRICK COUNTY COMMISSIONERS ORDINANCE NO. 2002- 06

AN ORDINANCE TO VACATE A UNDEVELOPED COMMUNITY PARK IN
HERITAGE PLACE THIRD ADDITION SUBDIVISION

BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS FOR
WARRICK COUNTY, INDIANA, as follows to wit:

Section 1. Pursuant to IC 36-7-3-12, a petition was presented to the Board of County Commissioners of Warrick County, Indiana, requesting that the Heritage Community Park as stated on Lot 3 of Heritage Place Third Addition Subdivision as Recorded in Plat File 1 Card 258 in the Office of the Recorder, Warrick County, Indiana, be vacated.

Section 2. That after due and proper notice, a public hearing was held by the Board of County Commissioners of Warrick County, Indiana, at which time all interested persons were permitted to address said Board.

Section 3. That the Board of County Commissioners of Warrick County, Indiana, after due investigation and consideration, have determined that the community park was never developed and that it is in the public's interest to vacate said park.

Section 4. This Ordinance shall be in full force and effect from and after it's passage by the Board of County Commissioners of Warrick County, Indiana.

Section 4. This Ordinance shall be in full force and effect from and after it's passage by the Board of County Commissioners of Warrick County, Indiana.


