AN ORDINANCE TO VACATE

THE WEST ONE HUNDRED EIGHTY (180) FEET OF THE FORTY (40) FOOT
WIDE RIGHT-OF-WAY OF WALNUT STREET LYING BETWEEN LOTS 24 AND
LOTS 25 IN CLARK'S ENLARGEMENT TO TAYLORVILLE, NOW SELVIN,
INDIANA AS RECORDED IN PLAT BOOK 1, PAGE 68 AS IN THE OFFICE OF
THE RECORDER OF WARRICK COUNTY, INDIANA.

Be it ordained by the Board of County Commissioners of Warrick County, Indiana as
follows:

1. Pursuant to IC 36-7-3-12 & 16, a petition was presented to the Board of County
Commissioners of Warrick County, Indiana, requesting that a THE WEST ONE
HUNDRED EIGHTY (180) FEET OF THE FORTY (40) FOOT WIDE RIGHT-OF-
WAY FOR WALNUT STREET LYING BETWEEN LOT 24 AND 25 IN CLARK'S
ENLARGEMENT TO TAYLORVILLE, NOW SELVIN, INDIANA AS RECORDED
IN PLAT BOOK 1, PAGE 68, IN THE OFFICE OF THE RECORDER OF WARRICK
COUNTY, INDIANA, Be vacated.
2. That after due and proper notice, a public hearing was held by the Board of County
Commissioners of Warrick County, Indiana, at which time all interested parties were
permitted to address said Board.

3. That the Board of County Commissioners of Warrick County, Indiana after due investigation and consideration, have determined that THE WEST ONE HUNDRED EIGHTY (180) FEET OF THE FORTY (40) FOOT WIDE RIGHT-OF-WAY OF WALNUT STREET LYING BETWEEN LOTS 24 AND 25 IN CLARK'S ENLARGEMENT TO THE TOWN OF TAYLORVILLE, NOW SELVIN, INDIANA AS RECORDED IN PLAT BOOK 1, PAGE 68 IN THE OFFICE OF THE RECORDER OF WARRICK COUNTY, INDIANA, is not being used and is not necessary, nor required and that it is in the public's interest to vacate said WEST ONE HUNDRED EIGHTY (180) FEET OF THE FORTY (40) FOOT WIDE RIGHT-OF-WAY OF WALNUT STREET LYING BETWEEN LOTS 24 AND 25 IN CLARK'S ENLARGEMENT TO THE TOWN OF TAYLORVILLE, NOW SELVIN, INDIANA AS RECORDED PLAT BOOK 1, PAGE 68 IN THE OFFICE OF THE RECORDER OF WARRICK COUNTY, INDIANA.

4. The Legal Description of said Public Road Vacation is:

The West one hundred eighty (180) feet of the forty (40) foot wide Right-of-Way of Walnut Street lying between Lots 24 and 25 in Clark's Enlargement to the Town of Taylorville, now Selvin, Indiana as recorded in Plat Book 1, page 68 in the Office of the Recorder of Warrick County, Indiana.

5. The County Auditor shall furnish a copy of the ordinance to the County Recorder to record.



