AN ORDINANCE TO AMEND THE WARRICK COUNTY, INDIANA  
COMPREHENSIVE ZONING ORDINANCE BY REZONING CERTAIN  
REAL ESTATE IN WARRICK COUNTY, INDIANA

**BE IT ORDAINED BY THE COUNTY COMMISSIONERS OF WARRICK  
COUNTY, INDIANA:**

Section 1. That the Warrick County, Indiana Comprehensive Zoning Ordinance and the Warrick County Zoning District Maps dated February 1, 2005, and made a part of said Ordinance, be and the same are hereby amended as follows:

That the boundaries of the R-1 One Family Dwellings shown on said Warrick County Zoning District Maps, be amended as to the following described real estate:

Part of Northwest Quarter of the Southeast Quarter of Section 20, Township 4 South, Range 9 West, Greer Township, Warrick County, Indiana, more particularly described as follows:


BEGINNING at the Northeast Corner of said Quarter Quarter Section; thence South 00° 06' 55" East, along the East line thereof, 200.0 feet; thence South 90° 00' 00" West - 398.01 feet; thence North 00° 06' 55" West - 28.72 feet; thence North 89° 59' 48" East - 251.57 feet; thence North 00° 48' 14" East - 171.28 feet to the North line of said Quarter Quarter Section; thence North 90° 00' 00" East, along said North line, 143.69 feet to the POINT OF BEGINNING and containing 0.833 acres, more or less.


which real estate is now zoned and classified as part of the R-1 District, as shown on the aforesaid Warrick County Zoning District Maps, so that said above described real estate shall be and the same is hereby rezoned and reclassified from said R-1 District to said AGRICULTURE District.

Section 2. All Ordinances and parts of Ordinances in conflict herewith are hereby repealed.

Section 3. This Ordinance shall be in full force and effect from and after its passage by the Board of Commissioners of the County of Warrick, State of Indiana.




