NOW, THEREFORE, BE IT RESOLVED by the Warrick County Council as Fiscal Body of Warrick County, and the Warrick County Board of Commissioners as the County Executive of Warrick County, that the contract attached hereto and incorporated herein be and the same is hereby approved and that the presiding officers of the Warrick County Council and the Warrick County Commissioners be and they are hereby authorized and directed to execute the same on behalf of Warrick County, Indiana.
