

ORDINANCE 2016- 20
AN ORDINANCE ESTABLISHING A BOOKING FEE FOR CONVICTED
PERSONS WHO ARE HOUSED IN THE WARRICK COUNTY JAIL

WHEREAS, Indiana Code §§ 36-1-3 et. seq. grants Warrick County the authority necessary to pass ordinances relating to the conduct of its business affairs, even though not specifically granted by statute; and

WHEREAS, pursuant to Indiana Code § 36-2-13-17.4, the Warrick County Sheriff has requested that the Warrick County Board of Commissioners establish a fee to be charged by the Warrick County Sheriff's Office for the processing of convicted persons housed in the Warrick County Jail in order to help defray the County's costs associated with the housing of such persons lodged in the Warrick County Jail; and

WHEREAS, the Warrick County Sheriff has requested that a Fifty Dollar (\$50.00) booking fee be collected by the Warrick County Sheriff's Office after sentencing by a Warrick County Circuit or Superior Court Judge with regard to convicted inmates who are detained in the Warrick County Jail; and

WHEREAS, the Warrick County Sheriff's Office shall deposit collected booking fees into the County's General Revenue Account under the Sheriff's Booking Fee Line Item.

NOW THEREFORE BE IT ORDAINED BY THE BOARD OF COUNTY COMMISSIONERS OF WARRICK COUNTY, INDIANA THAT:

The Code of Ordinances of Warrick County, Indiana, is hereby amended to provide for a new SECTION 32.05 entitled "Convicted Inmate Booking Fee" as follows:

(A) A booking fee of Fifty and 00/100 Dollars (\$50.00) is hereby established for those persons lodged in the Warrick County Jail who have been convicted in the Warrick County Circuit or Superior Court for a crime for which the person is to be incarcerated or held in the Warrick County Jail.

(B) The booking fee collected by the Warrick County Sheriff's Office shall be deposited into the County's General Revenue Account under the Sheriff's Booking Fee Line Item to help pay for the medical expenses for inmates lodged in the Warrick County Jail.

(C) Fees deposited into the County's General Revenue Account under the Sheriff's Booking Fee Line Item shall be used by the Warrick County Sheriff's Office to help cover medical expenses for inmates lodged in the Warrick County Jail, including but not limited to, the purchase of supplies, equipment or for training purposes as deemed necessary by the Warrick County Sheriff's Office.

(D) This Ordinance shall be in full force and effect from and after its passage by the Warrick County Board of Commissioners and following publication of the same in accordance with Indiana Code §§ 5-3-1 et seq.






