

AMENDED RESOLUTION NO. 2017-12

A RESOLUTION APPROVING ASSIGNMENT OF WARRICK COUNTY TAX SALE CERTIFICATES HELD BY THE WARRICK COUNTY COMMISSIONERS

WHEREAS, the Board of Commissioners of Warrick County (the "Commissioners") have acquired liens and received tax sale certificates on certain parcels of real estate in Warrick County pursuant to Indiana Code 6-1.1-24-6;

WHEREAS, the Commissioners and Boonville Now, Inc. have identified certain parcels upon which the Commissioners have acquired liens to be potentially appropriate to seek eligibility in the Blight Elimination Program (the "BEP") administered by the Indiana Housing and Community Development authority (the "Assignment Parcels");

WHEREAS, Boonville Now, Inc., a non-profit corporation with its offices and principal place of business in Boonville, Warrick County, Indiana, is willing to investigate the Assignment Parcels for eligibility in the BEP and to identify which of the Assignment Parcels are eligible for and should be submitted to the BEP; and

WHEREAS, the parties understand and acknowledge that Boonville Now, Inc., may not select all Assignment Parcels to the BEP; and

WHEREAS, the agreement by Boonville Now, Inc., to investigate and submit the Assignment Parcels to the BEP is further provided for in that certain Reimbursement Agreement entered into on or about April 20, 2017, by and between Boonville Now, Inc., and Warrick County and its Department of Economic Development (the "Reimbursement Agreement"); and

WHEREAS; the Commissioners have compiled a list of Assignment Parcels which is attached hereto as "Exhibit A";

WHEREAS, the Commissioners are authorized pursuant to Indiana Code 6-1.1-24-6.7 and Indiana Code 6-1.1-24-17 to transfer the tax sale certificates to nonprofit entities;

WHEREAS, Boonville Now, Inc., is willing to accept transfer to the lien certificates and accept the responsibility to follow the statutory requirements to obtain title to said properties at the sole cost and expense of Boonville Now, Inc., subject however to the reimbursement terms found in the Reimbursement Agreement;

WHEREAS, notice was published and a public hearing was held to discuss and hear any opposition to the transfer of certain lien certificates to Boonville Now, Inc., all pursuant to I.C. §6-1.1-24-17, and notice was issued to those municipalities as required pursuant to I.C. §6-1.1-24-6.2.


NOW THEREFORE BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF WARRICK COUNTY:

That the tax sale certificates for the properties identified on attached "Exhibit A" are hereby transferred from the Board of Commissioners of Warrick County to Boonville Now, Inc., a nonprofit entity, and Boonville Now, Inc. shall proceed according to the terms of the Reimbursement Agreement and to any statutory requirements to obtain title to said properties at the sole cost and expense of Boonville Now, Inc., but subject to the terms of the Reimbursement Agreement.


