**A RESOLUTION OF THE BOARD OF
COMMISSIONERS OF WARRICK COUNTY,
INDIANA OPPOSING THE CURRENT LLOYD EXPRESSWAY
CORRIDOR MANAGEMENT PLAN AND REQUESTING A
PUBLIC HEARING CONCERNING HIGH-TRAFFIC INTERSECTIONS**

WHEREAS, the Indiana Department of Transportation (“INDOT”) released a draft of the Lloyd Expressway (SR 62/66) Corridor Management Plan from St. Phillips Road to State Road 261 (the “Lloyd Expressway Corridor Management Plan”) in May, 2018. A copy of the Lloyd Expressway Corridor Management Plan stakeholder meeting PowerPoint presentation is attached hereto as Exhibit “A”; and

WHEREAS, the Board of Commissioners of Warrick County, Indiana, is concerned about the proposed roadway solutions detailed in the Lloyd Expressway Corridor Management Plan, and believe that greater local community input, including public hearings, regarding the high-traffic intersections along the Lloyd Expressway is necessary; and

WHEREAS, the Board of Commissioners of Warrick County, Indiana, oppose the current draft of the Lloyd Expressway Corridor Management Plan due in part to the lack of public input and the inadequate road improvement solutions detailed in the Lloyd Expressway Corridor Management Plan; and


WHEREAS, the Board of Commissioners of Warrick County, Indiana, respectfully requests that INDOT hold public hearings in Warrick County, Indiana, and Vanderburgh County, Indiana, regarding the Lloyd Expressway Corridor Management Plan prior to its final release; and

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Warrick County, Indiana, as follows:


That the Board of Commissioners of Warrick County, Indiana, is opposed to the current draft of the Lloyd Expressway Corridor Management Plan and hereby requests that public hearings be held in Warrick County, Indiana, and Vanderburgh County, Indiana, so that sufficient public comment can be obtained concerning the issues surrounding the high-traffic intersections along the Lloyd Expressway, thereby enabling the proposal of appropriate solutions by INDOT in the final, released plans so as to adequately improve future traffic flow and safety along the Lloyd Expressway.


