

**ORDINANCE NO. 2018-20**

**AN ORDINANCE OF THE BOARD OF  
COMMISSIONERS OF WARRICK COUNTY, INDIANA  
ESTABLISHING THE WARRICK COUNTY CASA DONATION FUND**

**WHEREAS**, Indiana's Home Rule statute (Ind. Code 36-1-3, *et seq.*) grants the Board of Commissioners of Warrick County, Indiana the power to create, by ordinance, funds that are necessary to conduct the affairs of the County; and

**WHEREAS**, the Board of Commissioners of Warrick County, Indiana has determined there is a need to establish a donation fund to support and maintain the Court Appointed Special Advocates ("CASA") Program in Warrick County, Indiana.

**NOW, THEREFORE, BE IT ORDAINED** by the Board of Commissioners of Warrick County, Indiana as follows:


The Board of Commissioners of Warrick County hereby establishes the Warrick County CASA Donation Fund for the specific purpose of providing citizens and organizations the ability to support and maintain the Warrick County CASA Program. Monetary donations made payable to the "Warrick County CASA Donation Fund" shall be placed in the Warrick County CASA Donation Fund. The application of funds donated to the Warrick County CASA Donation Fund shall be for administrative costs associated with operating the Warrick County CASA Program, including, without limitation, payment of employee and staff salaries.


The Warrick County CASA Donation Fund shall be perpetual until terminated by the terms of this Ordinance or by enactment of a subsequent ordinance or amendment. In the event the Warrick County CASA Donation Fund is terminated for any reason, the disposition of the fund balance, if any, shall be determined by the Board of Commissioners of Warrick County, Indiana.

This Ordinance shall be effective upon passage.
