

ORDINANCE 2019-15

**AN ORDINANCE OF THE BOARD OF COMMISSIONERS OF
WARRICK COUNTY, INDIANA, AMENDING THE WARRICK COUNTY
CODE OF ORDINANCES SECTION 37.37 REAL PROPERTY ENDORSEMENT FEES**

WHEREAS, the Warrick County, IN Code of Ordinances Section 37.37 currently sets forth certain fees the Warrick County Auditor may charge for real property endorsements made by the Auditor, pursuant to Ind. Code 36-2-9-18;

WHEREAS, Subsection (A) of Warrick County, IN Code of Ordinances Section 37.37 currently authorizes the collection of a fee in the amount of Five and 00/100 Dollars (\$5.00) for each real property endorsement made by the Auditor in accordance with Indiana law;

WHEREAS, Ind. Code 36-2-9-18(d) permits the Board of Commissioners of Warrick County, Indiana, to adopt an ordinance requiring the Warrick County Auditor to collect a fee in the amount of Ten and 00/100 Dollars (\$10.00) for each real property endorsement made by the Auditor in accordance with Indiana law; and

WHEREAS, the Board of Commissioners of Warrick County, Indiana, desires to authorize the Warrick County Auditor to collect a fee of Ten and 00/100 Dollars (\$10.00) for each real property endorsement made by the Auditor in accordance with Indiana law.

NOW, THEREFORE, BE IT ORDAINED by the Board of Commissioners of Warrick County, Indiana, that:

The Code of Ordinances of Warrick County, Indiana, Section 37.37 is hereby amended to read as follows:


- (A) The Warrick County Auditor is hereby authorized to collect a fee of Ten and 00/100 Dollars (\$10.00) for each deed, or legal description of each parcel contained in the deed, for which the Auditor makes a real property endorsement.
- (B) The fee herein authorized shall be in addition to any other fee provided by law.
- (C) The Warrick County Auditor shall place all revenues received in accordance with this Section 37.37 in a dedicated fund for use in maintaining plat books, in traditional or electronic format.




