**WHEREAS**, the Warrick County Board of Commissioners is the County Executive of Warrick County, Indiana; and

**WHEREAS**, the Warrick County Council is the Fiscal Body of Warrick County, Indiana; and

**WHEREAS**, Marvin D. Heilman is the Sheriff of Warrick County having assumed said office on January 1, 2007, with his term to expire on December 31, 2010; and;

**WHEREAS**, Indiana Code 36-2-13-2.5 provides for the entering into a contract between the Sheriff, the Executive and Fiscal Body for the provision of compensation for the Sheriff; and

**WHEREAS**, the Warrick County Commissioners and the Warrick County Council deem it to be in the best interest of Warrick County and its citizens that a contract exist between Warrick County through its County Executive and County Fiscal Body and its Sheriff for the provision of compensation for the Sheriff for calendar years 2007 and 2008 and to expire on December 31, 2008; and

**WHEREAS**, attached hereto and incorporated herein is a form of contract that the County Executive and Fiscal Body deem to be in the best interest of Warrick County and contains terms and conditions satisfactory to the County Executive and County Fiscal Body.
